2. Additional packs of files can be added or reduced throughout the year at the contract pricing as long as the overall yearly volume does not drop below the minimum purchase requirement of 300 packs/yr.
3. All hand files will be F.O.B from Miltex Inc, York, PA to the dental office according to the yearly, monthly or weekly schedule established by the office.
4. The dental office will be billed from its authorized dealer of choice.
5. The dental office will receive a discounted price on each pack of files as stated by the contract pricing program. The discounted price applies only to endodontic files and does not apply to other Miltex® products (no other discounts or promotions can be used in combination with the Endo Contract).
6. Discounted prices only apply to the following Miltex® hand files: Flex-R®, Sharpie® Hedstrom, Mor-Flex®, Onyx-R®, Onyx-H™ and Hi-5® hand files.
7. Miltex reserves the right to prohibit the participation of an individual if fraud or tampering is suspected or if the individual fails to comply with any requirement of participation as stated herein or with any provision in these rules.
